- Selection Process almost complete 19 total COSTEPs, 18 in Indian Health Service
- Important to get 1662s submitted to DCCPR so process for CAD can continue
- Other Agencies Interested?

Involuntary Separation/Retirement

- o 5 Pillars RADM Giberson restated DCCPR policy that all new CADs have a 1662 with an addendum that indicates which of the Five Pillars the new officer falls into. The Five Pillars include:
 - 1. Serving the needs of vulnerable or medically underserved populations,
 - 2. Serving in hardship locations or difficult to recruit positions,
 - 3. Being available for rapid deployment,
 - 4. Requiring regular engagement with other uniformed services,
 - 5. Addresses an important public health need but can only be filled with a Commissioned Corps officer

Based on RADM Giberson's memo, current officer billets will be evaluated in the near future to determine which Pillar the position meets. I've asked if that's a year or two years away but have not heard back.

 Best Kept Secrets Quarterly Review - DCCPR has assembled a professionally written custom marketing document for each category. It's really well done and describes the work of Environmental Health Officers as well as the benefits of the Commissioned Corps. M&R will be reviewing the document to ensure current information.

Jr. COSTEP Workgroup Report for December EHOPAC Meeting

- COSTEP Draft: The COSTEP Draft took place in mid-January (7th-10th and 22nd 24. To date, 19 COSTEPs were selected. 18 are tentative slated to go to IHS and 1 to CDC. There were 39 applications processed and DCCA is still receiving inquiries from OPDIVs that haven't selected a COSTEP to date, so the number may increase.
- o Article Submitted to AHAP: At the request of the Association for Healthcare Accreditation Professionals (body that accredits EH Universities), the M&R

subcommittee submitted an article describing the great career opportunities available in the USPHS Commissioned Corps including the COSTEP program.
