- <u>Fundraising:</u> No news unfortunately. I exchanged emails with CAPT Sanders last week and the issues still needs to go before the OSG.
- Call for New Voting Members Amendment: Call for new voting members: The initial call for new voting members went out in June. We assumed that we were replacing the two voting members from IHS and the one from CDC. But the distribution of officers across the service continues to shift. FDA continues to gain EHOs and IHS continues to lose officers. The stats you see below were pulled on June 4th, but since then the FDA and the IHS have reached parity with 92 officers each. In fact with the recent FDA hiring initiative, the FDA has likely surpassed the IHS. Regardless, based on the bylaws, we had to pull the numbers in June. IHS loses a seat and NIH gains a seat. Since the two at large seats were held by NIH, we moved CDR Derek Newcomer into the NIH seat and opened up an At Large seat. So, please consider becoming a voting member if you are assigned to IHS, CDC or one of the non-represented agencies.

IX. Liaison Reports

A. EHAC Liaison Report – CAPT Don Williams

- The 2015 Annual Environmental Health Accreditation Council met in Orlando, FL during the NEHA meeting.
- EHAC gained one graduate program: Fort Valley State University. They were placed on conditional accreditation for 2 years, the condition being that they need to provide evidence that their students are required to have "skills and knowledge of natural sciences including biological sciences, chemistry and other sciences". They are to document this by including this requirement in their program catalog.
- Additionally, University of Wisconsin-Stout was also discussed. They were not granted accreditation, but were given the status of pre-accreditation for two years. After this period they must re-apply for full accreditation.
- The second day of the meeting dealt solely with updating the Undergraduate Guidelines; we will not be operating under the new version of the guidelines until after they are put to vote at the 2016 Annual Meeting.
- We definitely are gearing up for a busy year! There are currently 8 programs going up for reaccreditation:

- Mississippi Valley State University may decide to move their Graduate program review up to 2016 as well so that they will only have to pay for one site visit (they originally were up for review in 2017). If they decide to move it up there will be 9 programs going up for reaccreditation.
- There are also two programs that are currently under Conditional Accreditation and must meet their conditions by 2016. These programs are Central Michigan University and West Chester University. Central Michigan University was supposed to have met their conditions by the 2015 Annual Meeting, but the council felt they did not meet conditions and are giving them an extra year.

Current Year Initiatives:

- Pilot Application Process 66 individuals applied to our category during the May open application window. 62 of those individuals were found to meet the category standards. We facilitated a scoring system and had 13 senior officers volunteer to help us rank order successful applicants. The top 50 applicants were given to DCCPR and will be completing the remainder of the application process. We do not have any updates on the status of these applications at this time.
- New EHOPAC Coin Design Congratulations to LCDR Christopher Fletcher and LT James Gooch for winning the coin design contest! The M&M Workgroup is busy working on the making the design a realty. We will let everyone know when these coins will be available for purchase. You can still purchase our current EHO coins by contacting CDR Jennifer Freed. The coins are \$10. Get your EHO historical coin before they run out!
- Recruit an EHO (RAE) This new work group is combining the Adopt-a-School program with opportunities to serve at professional events. We are creating a new policy document, an enrollment form, and a tracking tool to help us assist moving Officers forward with this new opportunity. 56 new volunteer opportunities have been identified for EHOs to volunteer to speak or recruit at local, state, and national associations and organizations across the Nation. Stay tuned for more information on the EHOPAC website and on the listsery.

Notable news/activities/accomplishments since last EHOPAC meeting:

- Board Clears 48 EHO Applicants Appointment boards met in April, May, June, July, and October of 2014 and in March and July of 2015 to clear and rank EHO general duty applicants. The board in March and July of 2015 were for former JRCOSTEPs that applied for general active duty this past year. During this process, the boards have cleared 48 officers for general duty thus far. Out of the 48 boarded EHOs, there are 6 available for hire; 20 have either secured positions or have pending 1662s; 7 have been medically disqualified, 1 individual has taken a non-USPHS job, 10 applications expired, and 4 withdrew their applications. We have sent this list of applicants to the POCs on the securing your first assignment brochure, liaisons and specific hiring managers. We have been helping to answer questions the applicants have by reaching out to appropriate agency contacts and liaisons, and EHOPAC leadership.
- General Active Duty Open Application Window The general active duty open application window is now closed as of COB Friday May 22 for all interested candidates who did not complete a JRCOSTEP. The M&R Subcommittee is working closely with the CPO and EHOPAC leadership to ensure we get the best qualified applicants reviewed in our pool by the appointment boards this year. The application window is still open for all individuals who have completed a JRCOSTEP since 2011. There is not a defined closing period yet. Interested applicants need to start by calling the PHS Call Center. The PHS Call Center phone number is 800-279-1605 and details are on the USPHS website at: http://www.usphs.gov/apply/apply.aspx. All applicants must meet the degree requirements for the category that they are applying for in order to be eligible.
- <u>2015 JRCOSTEP Open Application Window</u> The JRCOSTEP open application window has closed. There were 57 EHO applications and 25 EHO students were

selected. The students are working at Indian Health Service (20), FDA (2) and at CDC/NIOSH (3) in three separate locations (Atlanta, Anchorage, and Cincinnati). We welcome LCDR Angela Hodge as the new Co-Chair of the JRCOSTEP workgroup. I want to give LT Corey Butler a huge thank you for all her hard work as former Co-Chair of this workgroup. We have created a contact list this year for all the students so they would have each other's contact information at all duty sites across the nation. We have also completed the development of a timeline for the JRCOSTEP application process and we are waiting to get this online. We will be collecting student narratives from all students this year by working with their preceptors. Stay tuned for more information on that. Finally, CDR Shugart was invited to the annual EHAC meeting in Orlando, Florida this year and she gave a presentation on the status of the COSTEPs and General Active Duty application process on July 11, 2015.

Notable news/activities/accomplishments since last EHOPAC meeting:

- The EHOPAC Resources Workgroup has completed the update and conversions of the EHOPAC Utilization Guide, the EHO Marketing Pamphlet, and the Environmental Health Readiness Guide. These documents will be posted as ePub documents on the EHOPAC website.
- The last basic readiness check was run on July 1, 2015
 - o The EHOPAC is currently #2 for overall readiness at 92.98%, the HSO category is currently #1 for the highest number of officers meeting basic readiness at 95.94%.
 - We had a total of 37 Officers who failed to meet basic readiness. Six were missing their five year medical exam, four were missing the APFT, three were missing BLS training, and the remaining Officers were failing to meet multiple readiness requirements.
- Cross Category Readiness Workgroup Meeting update- during our most recent CCRWG meeting, the topic of repeat instances of Officers failing to meet basic readiness was discussed. RedDog provided a spreadsheet which detailed which Officers failed to meet basic readiness over the past five years. Increased focus is being directed at Officers who fail to meet basic readiness, particularly those who repeatedly fail to meet basic readiness requirements.
- RedDog has initiated a project to identify category specific skills, in addition to
 specialized experience and certifications possessed by Officers. Examples of the
 skills and certifications identified for EHOs include, but are not limited to RS,
 REHS, CP-FS, Hazwopper, CIH, experience inspecting wells, septic systems,
 temporary food establishments, etc. A draft of the EHO category specific skills and
 experience has been developed. It is anticipated that a survey will be developed and
 distributed to all EHOs to help RedDog identify Officers who possess skills,
